II. **BUSINESS**

This will be an opportunity for RAD Ullman to explain the upcoming changes to Region VII's constitution and bylaws, and the effect this will have on how Region VII is governed.

B. MARCH IN MARCH| LAD GAN| 15 MIN

This will be an opportunity for the region to summarize which ASO's are coming to Sacramento, and plan for local legislative visits for those who are not coming to Sacramento.

VI. COMMUNICATIONS FROM THE FLOOR

This time is reserved for any committee members to make announcements on items not on the agenda. A time limit of two (2) minutes per speaker shall be observed. No action will be taken and the total time limit for this item shall not be extended.

VII. PUBLIC COMMENT

This segment of the meeting is reserved for persons desiring to address the SSCCC Region VII Delegate Assembly on any matter of concern that is not stated on the agenda. A time limit of three (3) minutes per speaker and fifteen (15) minutes per topic shall be observed. The law does not permit any action to be taken, nor extended discussion of any items not on the agenda. The SSCCC Region VII Delegate Assembly may briefly respond to statements made or questions. The Chair will see to the item of discussion being placed on a future agenda (Brown Act §54954.3).
